## DIRECTIONS FOR USE

Application	Foliar
Rate	48 oz. per acre or 1.1 oz per 1,000 sq. ft
Mixture	30+ gallons of water/fertilizer/herbicide solution*
Placement	Broadcast
Timing	4+ times per season

**\*The use of a water conditioner is recommended.**

## Mixing Instructions

It may be combined with water, UAN, fertilizer and herbicide solution using agitation during mixing. Agitate before and during each application to ensure a uniform mixture.

## Caution

Keep out of reach of children. Harmful if swallowed. Avoid contact with eyes. May cause eye and skin irritation. In case of contact, wash affected area with water immediately and keep washing for 15 minutes. Consult a doctor if irritation persists.
